October, 2016

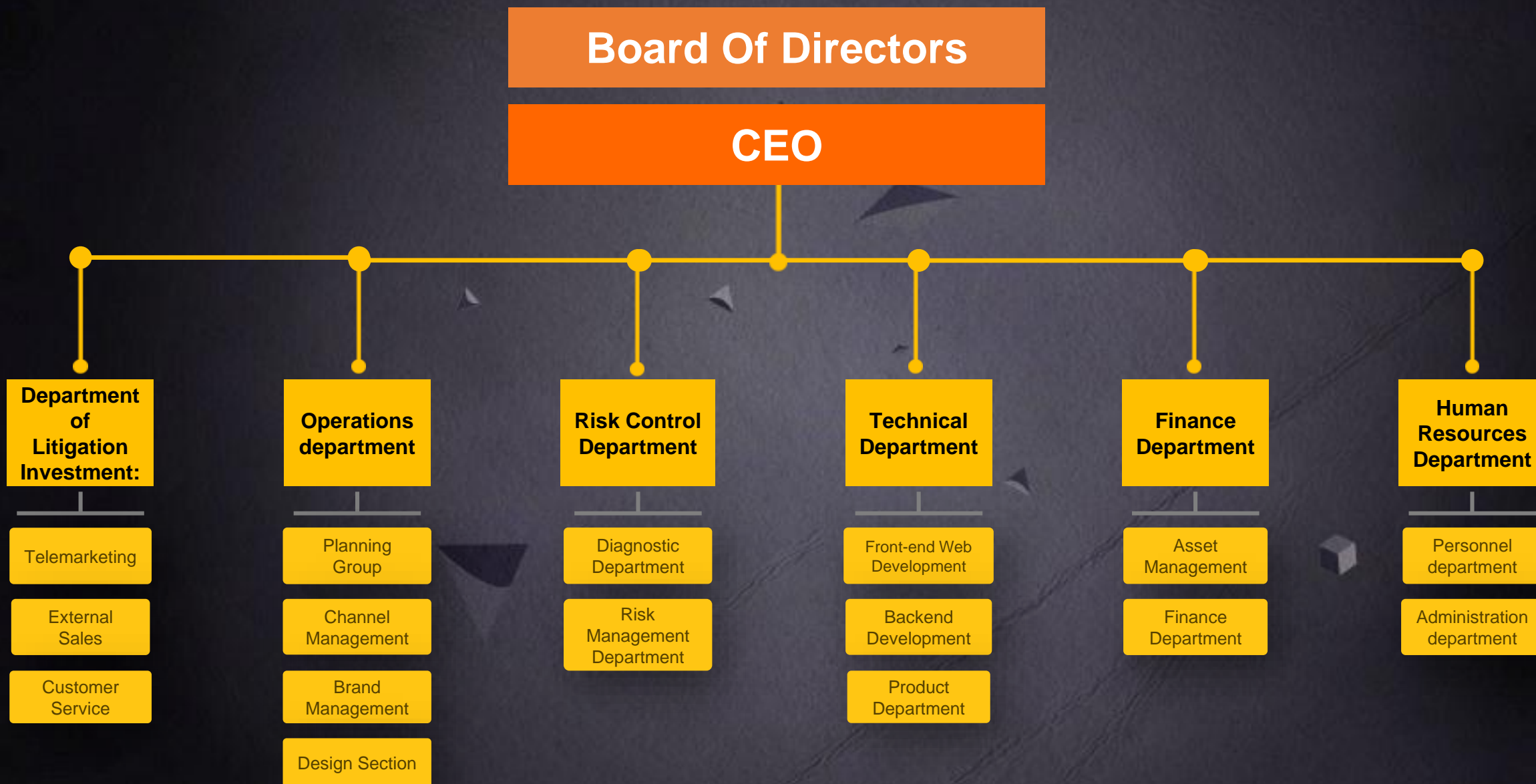

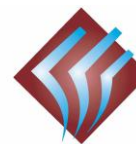
